Nunavut
Residents returning from Churchill, MB or Nunavik, QC for domestic leisure travel are not required to self-isolate; those returning from all other parts of Canada who are not fully vaccinated must isolate for 14 days at designated sites

IV Inter-Provincial 2.5

Northwest Territories
Fully vaccinated residents returning from outside of the territory for domestic leisure travel are not required to self-isolate, but testing for those arriving in smaller communities; those who are partially vaccinated must self-isolate for 8 days and those who are unvaccinated for 10 days

IV Inter-Provincial 6.6

Yukon
No self-isolation requirements for residents returning from out-of-province for domestic leisure travel

British Columbia
No self-isolation requirements for residents returning from out-of-province for domestic leisure travel

Alberta
No self-isolation requirements for residents returning from out-of-province for domestic leisure travel

Saskatchewan
No self-isolation requirements for residents returning from out-of-province for domestic leisure travel

IV Inter-Provincial 63.4

Manitoba
Fully vaccinated residents returning from outside of the province for domestic leisure travel are not required to self-isolate; 14 day self-isolation required for those who are not fully vaccinated

IV Inter-Provincial 13.1

Ontario
No self-isolation requirements for residents returning from out-of-province for domestic leisure travel

IV Inter-Provincial 20.9

Quebec
No self-isolation requirements for residents returning from out-of-province for domestic leisure travel

IV Inter-Provincial 28.0

New Brunswick
No self-isolation requirements for residents returning from out-of-province for domestic leisure travel

IV Inter-Provincial 7.2

Newfoundland and Labrador
Residents returning from Atlantic provinces for domestic leisure travel are not required to self-isolate; those returning from other parts of Canada who are unvaccinated must self-isolate until receipt of a negative test result taken on day 7 or later

IV Inter-Provincial 0.8

Prince Edward Island
Residents returning from Atlantic provinces for domestic leisure travel are not required to self-isolate if they have at least one vaccine dose and a PEI Pass; those returning from all other parts of Canada who are not fully vaccinated must self-isolate for 8 days

IV Inter-Provincial 3.8

Nova Scotia
Residents returning from Atlantic provinces for domestic leisure travel are not required to self-isolate; those returning from all other parts of Canada who are partially vaccinated must self-isolate for 7 days and those who are unvaccinated for 14 days

IV Inter-Provincial 1.9

Please note: An increase in search and bookings does not imply that residents are non-compliant with any current health restrictions in place, rather that there is an increased interest in travel. Actual travel could take place in the near future or at a later date.
